1. We have audited the accompanying Statement of Financial Results for the year ended 31st March, 2017 of Bella Casa Fashion and Retail Limited ("the Company") (hereinafter referred to as "the Statement") attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

This Statement, which is the responsibility of the Company's Management and approved by the Board of Directors, has been compiled from the related Financial Statements which has been prepared in accordance with the Accounting Standards prescribed under Section 133 of the Companies Act, 2013 read with the relevant rules issued thereunder and other accounting principles generally accepted in India. Our responsibility is to express an opinion on the Statement based on our audit of such financial statements.

2. We conducted our audit in accordance with the Standard on Auditing issued by the Institute of Chartered Accountants of India. Those standards require that we comply with the ethical requirement and plan and perform the audit to obtain reasonable assurance about whether the Statement is free from material misstatement.

Figures for the half year ended 31st March 2016 have been arrived at by reducing the estimated figures for the half year ended 30th September 2015 as arrived while publishing results for half year ended 30th September 2016 from the audited figures in respect of the full financial year ended 31st March 2016.
- The Company is engaged in production and retail of apparels and home furnishing products having integrated working. For management purposes, Company is organized into major operating activity of the textile products. The company has no activity outside India except export of textile products manufactured in India. Thereby, there is no geographical segment. Accordingly, segment-wise information is not being reported.
- The Company had issued 47,15,000 number of bonus equity shares of Face Value Rs. 10/- each during the previous year(2015-16) on at a ratio of 2.3:1 (i.e. 2.3 equity shares for every one equity share held) by capitalization of surplus. The Company had made an Initial Public Offer of 24,50,000 number of Equity Shares of Rs. 10/- each during the previous year at a price of Rs. 14/- each and allotment was made on 16th October, 2015. As per objects stated in prospectus funds raised from IPO of Rs 343 Lacs have been utilized for meeting the working capital requirement and share issue expenses.
- The figures of the corresponding previous year / periods have been restated/regrouped wherever necessary to make them comparable.
